We delivered 14,658 person-hours of program content to these individuals. We partnered with 46 agencies to deliver these services. We trained and supported 66 instructors of Parenting by Connection. We distributed 12,000 parenting booklets, 77 books, 2100 CD's and 118 parenting DVDs.
We sent monthly information and support to 8,000 subscribers, and averaged 10,000 website visits per month.
